Notified Bodies

- The Earl of Kinnoull, a member of the House of Lords EU Select Committee, question on Notified Bodies for EURIS has now been answered, please find the full question and answer below:
- Lord Kinnoull: To ask HMG to issue a statement confirming that UK Notified Bodies can continue to work with UK manufacturers, checking their products confirm to the essential requirements of European Directives which have also been transposed into UK law, until the end of the implementation period.
- Lord Henley (Parliamentary Under Secretary of State at BEIS): The Government recognises the valuable work undertaken by UK Notified Bodies in ensuring that products placed on the market have been through suitable assessment to ensure they comply with the relevant requirements. During the implementation period the UK will no longer be a Member State of the European Union, but market access will continue on current terms. For UK Notified Bodies this means that they will continue to be able to conduct third-party conformity assessments for both the UK and the EU markets as they do now.

Political News

- The Secretary of State for Northern Ireland is in Brussels today (25th June) to meet Michel Barnier, the European Union's Chief Negotiator. During her visit, she will reinforce her commitment to upholding Northern Ireland's interests as the UK prepares to leave the EU and try to secure a deal on the border https://www.gov.uk/government/news/secretary-of-state-to-meet-michel-barnier-in-brussels
- Donald Tusk, President of the European Council, will be visiting Theresa May in Downing Street this afternoon ahead of the Council meeting later this week.
- The European Council meets later this week and on Friday Michel Barnier will update the EU27 heads of state or government on the state of play of the talks. The focus will be on 1) completion of work on withdrawal issues, 2) issues related to the border between Ireland and Northern Ireland and 3) discussions on the framework for the future relationship with the UK http://www.consilium.europa.eu/en/meetings/european-council/2018/06/29/
